

An ordinance granting C.A.Tooke and J.E.Reynolds, their agents and assigns a Franchise or right to maintain and operate an electric light plant in the Town of Dubach Louisiana, furnishing the citizens with electric lights and fixing the charge for said lights and repealing all ordinances in conflict herewith.

Section # 1.

Be it ordained by the Mayor and the Board of Aldermen of the Town of Dubach La in a call session convened, that C.A.Tooke and J.E. Reynolds their agents and assigns, be and are hereby granted the right to construct, maintain and operate an electric light plant in the Town of Dubach La with the rights to use the streets of said Town to put up poles, wires and other appliances necessary in carrying on and operating an electric light plant and furnishing lights to the citizens of the Town.

Section # 2.

Be it further ordained that the said C.A.Tooke and J.E.Reynolds their successors and assigns shall keep said electric plant, poles, wires, transformers and other appliances in good repair and in such condition as not to endanger the lives of patrons or cause damage to property.

Section # 3.

Be it further ordained and etc, that the said C.A.Tooke and J.E. Reynolds, their successors and assigns shall furnish lights to the citizens of the Town of Dubach La or to any citizen who shall have his house wired in such a manner to use electric lights and shall demand that lights be furnished, provided that they shall not be required to furnish lights to its citizens on the outskirts of the Town where the cost of running lines to such house would be greater than the revenue would justify.

Section # 4.

Be it further ordained and etc, that all users of electric current throughout said Town shall be required to install meters and the said C.A.Tooke and J.E.Reynolds their successors and assigns shall have the right to make the following charges for current furnished to the citizens of the Town, to wit:- Twenty Cents per Kilowatt hours consumed provided that the minimum charge for any month shall not be less than \$2.22 for each house or person furnished with lights or electric current under this franchise, provided that a discount of ten per cent shall be allowed on all charge for lights and current furnished, if said charge is paid on or before the tenth of current month.

Section # 5.

Be it further ordained and etc, that this ordinance shall become effective and binding and shall have full force and effect from and after the written acceptance of its terms and provisions, by the said C.A.Tooke and J.E.Reynolds and its adoption by the Mayor and Board of Aldermen of said Town of Dubach La.

Section # 6.

Be it further ordained and etc, that this franchise and the rights granted herein shall be in full force and effect for a period of Twenty five years from date hereof.

Section # 7.

Be it further ordained and etc that all ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed, thus done, passed and signed on this the 7th day of April 1925.
