# Section II.

That Section 13-17, <u>Streets</u>, be amended by adding (g) <u>Posting designated street or road addresses</u>. to read as

- owner or occupant or person in charge of any house or building to which a number has been assigned will be notified in writing by the Lincoln Parish Communications District as to their assigned property number. Property numbers shall be displayed within 60 days of written notification or passage of this ordinance. It shall be the duty of such owner or occupant or person in charge thereof upon affixing the new number to remove any different number which might be mistaken for or confused with, the number assigned to said street/road. Each resident of Lincoln Parish shall, upon notification, display structure numbers in the following manner:
  - House numbers shall be at least four (4)
    inches in height .
  - House numbers shall be set on a background of contrasting color.
  - 3. When a house is such a distance from a road that house numbers cannot be seen or read, or when view of the house is blocked by trees or shrubs, the house numbers shall be on a sign attached to a post, tree, fence or gate beside the driveway readable from both
    - On a corner lot, the house number shall be on the mailbox as well as the house.
  - In rural areas the house number shall be on the mailbox as well as on the house.
  - House numbers shall be illuminated or made of a reflective material that is easily visible at night.
  - 7. House numbers shall be in plain block number rather than script.
  - 8. Apartment owners/managers and mobile home park owners/managers of single or complex units shall display lot or apartment numbers in the same manner as listed above.

# SECTION III.

That all ordinances or partial ordinances in conflict with this ordinance are hereby repealed.

### SECTION IV.

That this ordinance shall be in full force and effect upon promulgation.

AN ORDINANCE OF THE PARISH OF LINCOLN, STATE OF LOUISIANA, PROVIDING THAT CHAPTER 13 THE CODE OF ORDINANCES OF THE PARISH OF LINCOLN, STATE OF LOUISIANA, BE AMENDED BY REVISING ARTICLE II. GENERAL REQUIREMENTS AND MINIMUM DESIGN STANDARDS, SECTION 13-17, (e) STREET NAMES, AND ADDING SECTION 13-17 (g) POSTING DESIGNATED STREET OR ROAD ADDRESSES.

BE IT ORDAINED by the Police Jury of Lincoln Parish, Louisiana, in regular session convened this 14th day of July, 1992:

# SECTION I.

That Section 13-17, <u>Streets</u>, (e) <u>Street names</u> be amended so that said section shall read as follows:

- (e) Street or road names. Proposed streets obviously in alignment with existing streets. The following conditions and guidelines shall be adhered to in naming roads or streets in Lincoln Parish, Louisiana:
  - All parish street or road names are the responsibility of the Lincoln Parish Police Jury in the Parish of Lincoln.
  - No street or road name shall duplicate or closely approximate any previously named road in Lincoln Parish.
  - 3. After adoption of a street/road name it may not be changed except by formal request to the Lincoln Parish Police Jury, followed by a Public hearing. The formal request shall be accompanied by a petition signed by not less than 51% of the present residents on the street/road in question.
  - Complete street/road names shall be no greater than (15) fifteen spaces to accommodate placement on street/road signs.
  - 5. Actual cost incurred by the Lincoln Parish Police Jury when street/road names are changed shall be the responsibility of party or parties requesting the change.
  - 6. Only parish roads, city streets, and private drives that are at least 1/4 mile long or longer or have more than one resident facing the street/road shall be named.
  - 7. State and Federal highways shall, in all areas outside of municipalities, use their numbers in lieu of names.

- 8. Private street/roads that are named shall have a street/road sign conforming to the specifications of the Lincoln Parish Police Jury.
- The naming of private streets/roads shall in no way be construed to be an acceptance of private streets/roads into the parish road
