ORDINANCE NO. 153-A

AN ORDINANCE TO REVOKE, SET ASIDE AND ANNUL THE DEDICATION OF THE STREETS, PARKWAYS, BOULEVARDS AND CIRCLES OF THE SCHOOLVIEW ADDITION TO THE TOWN OF DUBACH, LINCOLN PARISH, LOUISIANA, AS PER PLAT OF RECORD IN COB BOOK 129 PAGE 124 IN THE OFFICE OF THE CLERK OF COURT, LINCOLN PARISH, LOUISIANA.

WHEREAS it appears that the streets, parkways, boulevards and circles of the Schoolview Addition have been dedicated to the use of the public, as will appear from the Plat of said Subdivision recorded in COB Book 129 page 124 of the records of Lincoln Parish, Louisiana, and

WHEREAS said streets, parkways, boulevards and circles are all being within the corporate limits of the Town of Dubach, Lincoln Parish, Louisiana, and said streets, parkways, boulevards and circles have never been opened or used by the public except said street along the East side of said subdivision; and

WHEREAS said streets, parkways, boulevards and circles serve no useful purpose in that other dedicated streets as shown on said plats of the Re-subdivisions of the Schoolview Addition allow ingress and egress to the property lying necessary or needed for public purposes, except for the street along the East Side of said subdivision; and

WHEREAS it is the desire of this body to revoke any dedications of streets, parkways, boulevards and circles previously made by the plat of the Schoolview Addition as per plat in COB Book 129 page 124, of record in the office of the Clerk of Court, Parish of Lincoln, Louisiana, except for the street along the East side of said subdivision;



NOW THEREFORE, the following ordinance is hereby enacted:

**Section 1**


BE IT ORDAINED by the Town Council for the Town of Dubach, Lincoln Parish, Louisiana, that the dedication of streets, parkways, boulevards, and circles to the public use of the Schoolview Addition, Town of Dubach, Lincoln Parish, Louisiana, be and it is hereby revoked, set aside, annuled and abandoned as not being necessary or needed for public purposes, except for the street along the East side of said subdivision.


**SECTION 2**

BE IT FURTHER ORDAINED that the property embraced within the limits of said streets, drives, boulevards and circles revoked herein, except the street along the East side of said subdivision, Town of Dubach, Lincoln Parish, Louisiana, is to revert to the property owners contiguous thereto:

**SECTION 3**

BE IT FURTHER ORDAINED that all ordinances in conflict herewith are hereby revoked.
