THEREFORE, BE IT INSTITUTED ON THIS 9 The DAY OF Cuguat, 1971.

THIS FUND SHALL BE OBTAINED FROM DONATIONS BY INTERESTED PARTIES
AND TRANSFER OF FEES RECEIVED FOR THE SALE OF LOTS AS DEEMED NECESSARY
BY THE TOWN COUNCIL.

THIS FUND SHALL BE PLACED UPON DEPOSIT IN A LOCAL INSTITUTION OF BANKING, WHERE IT WILL ACCUMULATE UNTIL IT REACHES AN AMOUNT OF \$5,000 OR MORE. IT SHALL BE PLACED ON DEPOSIT TO DRAW. INTEREST AT THE PREVAILING RATE. THIS INTEREST SHALL BE ADDED TO THE FUND UNTIL SUCH TIME AS THE FUND REACHES THE DESIRED AMOUNT.

THIS BASE FUND WILL NOT BE USED UNDER ANY CONDITIONS. THEREFORE, ONLY
THE INTEREST RECEIVED FROM THIS PERPETUAL FUND WILL BE USED FOR THE MAINTENANCE
OF THE HAMILTON MEMORIAL CEMETERY..

THIS FUND SHALL BE THE RESPONSIBILITY OF THE MAYOR AND THE TOWN COUNCIL AND THE LIMIT THEREFORE SHALL BE DETERMINED ACCORDING TO NEEDS.

MAYOR TOWN OF DUBACH

An ORDINANCE regulating the drinking or consumption of spiritous liquors or intoxicants and light wines and beer with in the corporate limits of The Town Of Dubach, Louisiana and providing for a penalty for violating said regulation and repealing all ordinances or parts of ordinances in conflict here with.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMAN OF THE TOWN OF DUBACH, LOUISIANA, in regular session convened that hereafter it shall be unlawful, except as other wise herein provided, for any person to drink or consume any spirituous, vinous, or malt liquors or intoxicants in any public place within the corporate limits of The Town Of Dubach, Louisiana.

SECTION 2. BE IT FURTHER ORDAINED, etc., that it shall be unlawful for any person to drink or consume light wines or beer in any public place within the corporate limits of The Town Of Dubach, Louisiana, except on the premises where such light wines or beer may be lawfully purchased and served.

SECTION 3. BE IT FURTHER ORDAINED, etc., that any person violating the provision of this ordinance shall, upon conviction, be fined not more than \$100.00 or imprisoned not longer than thirty days, or both, at the discretion of the Court.

SECTION 4. BE IT FURTHER ORDAINED, etc., that the immediate need for regulation as herein provided for is urgent and a public nuisance and emergency as regard public drinking exist; that the provisions of this ordinance should and shall become effective immediately upon its passage and adoption and all ordinances or parts of ordinances in conflict herewith are thereby repealed.
