ORDINANCE NO. 172

AN ORDINANCE PROHIBITING THE SALE OF ALCOHOLIC BEVERAGES CONTAINING MORE THAN 3.2 PERCENT ALCOHOL BY WEIGHT WITHIN THE CORPORATE LIMITS OF THE TOWN OF DUBACH, PROVIDING THE EFFECTIVE DATE AND PENALTIES FOR THE VIOLATION THEREOF.

WHEREAS, a local option election was called by the Police Jury of Lincoln Parish, Louisiana, by Ordinance No. 367, submitting to the electors of Ward Four of Lincoln Parish, Louisiana, including the municipalities of Dubach and Vienna, the following three propositions, to-wit:

- (1) Shall the sale of beverages of low alcoholic content containing more than three and two-tenths percent alcohol by weight, and not more than six percent alcohol by volume, be permitted in Ward Four, Lincoln Parish?
- (2) Shall the sale of beverages of high alcoholic content containing more than six percent by volume for consumption on the premises be permitted in Ward Four, Lincoln Parish?
- (3) Shall the sale of beverages of high alcoholic content, containing more than six percent alcohol by volume by the package only and not for consumption on the premises be permitted in Ward Four, Lincoln Parish, Louisiana?

WHEREAS, the election was duly held in Ward Four, Lincoln Parish, Louisiana, including the municipalities of Dubach and Vienna, on October 8, 1974, and,

WHEREAS, the Board of Supervisors of Elections of Lincoln Parish, Louisiana canvassed the returns of said election with the following results:

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dubach, Louisiana, in regular session convened, that:

SECTION 1: The sale of alcoholic beverages containing more than three and two-tenths percent alcohol by weight be and the same is prohibited within the corporate limits of the Town of Dubach, Louisiana.

SECTION 2: BE IT FURTHER ORDAINED, etc., that each sale made in violation hereof shall constitute a separate offense.

SECTION 3: BE IT FURTHER ORDAINED, etc., that any person, firm or corporation who shall violate the provisions of this ordinance or any portion thereof shall be guilty of a misdemeanor and upon conviction shall be fined not more than One Hundred and No/100 ths (\$100.00) Dollars, or imprisoned for not more than thirty (30) days or both.

SECTION 4: BE IT FURTHER ORDAINED, etc., that this ordinance shall become effective on the _____ day of November, 1974.

SECTION 5: BE IT FURTHER ORDAINED; etc., that all ordinances or parts of ordinances in conflict with this ordinance be and the same are hereby repealed.

SECTION 6: BE IT FURTHER ORDAINED, etc., that if any provision of this ordinance is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications, and to this end the provisions of this ordinance are hereby declared severable.
