Be it ordained by the Mayor and the Board of Aldermen of the Town of Dubach La in regular session convened; That for the year 1911 and for each and every subsequent year, there Shall be and is hereby levied an annual license tax to be paid to the Town of Dubach Laupon every person, business, firm and corporation pursueingwithin the Town of Dubach La any trade, profession, vocation, call ing or business that is subject to a license tax under the laws of the State of La which said license tax is is hereby fixed, graduated and levied in amounts equivalant to the license tax levied by the State of Louisiana for the same and si ilat grade and volume of business except in case speciallyprovided for in succeeding sections of this ordinance, provided that no license shall issue for a less sum than \$5.00 per annum, nor a shorter period than six months. Section Number 2, Nothing herein contained shall be construed to authorize the issuance of a license to retailors of spirituous or intoxicating liquors nor for the oursuit of any business or calling that is prohibited within the Town of Dubach La. Section Number 3, That each and every Life, accident, tornado, lightning Insurance, guaranty, surety or indemnity company, society, association, corporation or other organization firm or individual oursueing or conducting any insurance, guaranty, surety or indemnity business within the Town of Dubach La, wheter domiciled here or operating through a branch department, resident or local office, agent, individual, form or corporation shall pay a seperate and distince license based on the gross annualxies CEME premium on all risks located within the Town or located elsewhere and contarcted forwithin or from offices located within the Town as folix 1st class; When the annual premium are one thousand dollars or less the 1 2nd Class; When annual or over \$1,000.00 and less than \$2,000.00 the li-3rd Class; When the annual premiums are over \$2000.00 and less than \$3000.00 the license shall be \$25.00 4th Class; When the annual premiums are over \$3000 and less than \$5000 5th Class; When the annual premium is over \*555545 \$5000 the license shal the license shall be \$40.00 be \$50.00 provided that all companies, societies, associations, organizations or individual or their Agents, applying for or subject to a license tax under this section sahll present to the tax collector a certificate from the Secretary of the State showing its authority to do business within the State and shall also presents a certificate under oath showing the gross annual receipts by said company, society, association, organization, or individual during the previous year. Sec 4. Ordinance No 20 Continued, the ,license shall be \$20.00 Section No 7; -All license was herein provided for shall be due and payable /-/- /9// andafter this year to become due and pay able on the 1st day of January and become delinquent on the first day of March of each and every year and the penalty of 2% per cent per month is hereby assessed for the nonpayment from date of delinquincy. The Mayor and Clerks are authorized to issue said license and the Tax Collevtor shall collect the same together with costs provided provided by law for the collection of state license or as herein provided. If any person, association of persons, firm, corporation or organization or any agent, Clerk, employees or representatives of the same shall pursue y business, calling, vocation, trade or profession without first having tainedlicense as herein provided; after the time provided for the payint of said license sahl I have expired, The Mayor shall issuean order com ading him or them to show cause on the 5th day, exclusive holidays, after ie service of such order or on any day thereafter to be fixed by the Mayr why such person, association, of personsx, firm or corporation should not ay a licenseas herein provided; and if uponhearing it shall be found aht a license is due, such person, firm or corporation, or agent, clerk.employee or representative of the same shall be ordered to cease the pursuit of such business, calling, trade, vocation or profession and every violation of such order Shall be deemed a contempt and a violation of this ordinance and shall be punished by a fine of not less that \$5.00 or imprisioned at the discretion of the Mayor, and each day such violation continues shall be deemed a seperate offense. At any time after a license shall have become due as herein provided, The Mayor is authorized to proceedto collect the same together with penalties and costs in any court of competent jurisdiction in the manner authorized and provided by law. Provided further, That Museums, circusses, streetv fairs or other traveling showsor exibition, peddlers, hawkers and all travelingitinerant persons shall be prohibited from giving any exibitions or pursueing any business whatever until a license shall have been first obtained, and every person wh ther Proprietor, or Manager, performer or other employees or attaches violating any of the provision of this ardinacne or section shall upon onviction be fined not less than \$5.00 nor more than \$100.00 or imprisoned not less than thirty days, assed by the following vote, YEAS, Dr J.L.Smith, R.L.Cox.
