

ORDINANCE NO. 240

AN ORDINANCE DECLARING THREE PLOTS OF LAND IN THE TOWN OF DUBACH AS SURPLUS AND SETTING MINIMUM BIDS ON EACH.

SECTION 1: BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DUBACH, STATE OF LOUISIANA, acting as the governing authority of said Town, that the following three plots of land have been declared as surplus and minimum bids have been set as follows:

Plot No. 1 Minimum Bid \$6,000.00

Beginning at the NW corner of Stephen E. Heard's lot and run North 210 feet; thence East 210 feet; thence South 210 feet; thence West 210 feet, containing one acre, more or less, located in the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 26, Township 20 North, Range 3 West, Lincoln Parish, Louisiana.

Plot No. 2 Minimum Bid \$4,000.00

Starting at the Southeast Corner of Effie Brasier's lot in Block 1, McMullen Addition, Town of Dubach, and run South 80 feet along the West side of South Main Street, thence West 90 feet; thence North 80 feet; thence East 90 feet, all in the Town of Dubach, Lincoln Parish, Louisiana.

Plot No. 3 Minimum Bid \$4,000.00

Beginning at the NE corner of James Edward Broughton's lot and run South 138 feet, thence East 138 feet, thence North 138 feet, thence West 138 feet to the point of beginning. All in the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 26, Township 20 North, Range 3 West, Town of Dubach, Lincoln Parish, Louisiana.

SECTION II: BE IT FURTHERMORE ORDAINED, etc., that this Ordinance shall be published in the official Minutes of the Mayor and Board of Aldermen in the manner provided by law.
