AN ORDINANCE REDISTRICTING THE TOWN OF DUBACH, LINCOLN PARISH, LOUISIANA, PURSUANT TO THE UNITED STATES CENSUS FOR THE YEAR 2000, MAINTAINING THE FIVE SINGLE MEMBER DISTRICTS FOR THE ELECTION OF MEMBERS OF THE BOARD OF ALDERMEN OF DUBACH.

WHEREAS, the United States Census for the year 2000 has been completed and under the laws of the State of Louisiana, the Town of Dubach is authorized to redistrict the five (5) single member Districts for the members of the Board of Aldermen of Dubach pursuant to the 2000 census population numbers, the Board of Aldermen of the Town of Dubach, by appropriate ordinance, hereby proposes the new Ward lines described below, subject to submission for approval by the United States Department of Justice pursuant to the Voting Rights Act of 1965.

Section 1. BE IT ORDAINED by the Board of Aldermen of the Town of Dubach that the Town of Dubach shall be and is hereby divided into five (5) Wards lettered and with the boundaries fixed and defined as follows:

Ward A (1)

Ward A (1) is all that area within the Town limits of Dubach lying within the following described line:

from a point of beginning at the intersection of Henry Street and Seth Street; thence east along Seth Street to the intersection of Larry Street; thence south along Larry Street to the intersection of Hico Street; thence east along Hico Street to the intersection of Church Street; thence north along Church Street to the intersection of Wynn Street; thence east along Wynn Street to the intersection of McMillan Street (US Hwy 167);

thence north along McMillan Street to the intersection of Smith Street; thence east on Smith Street to the intersection of Main Street; thence south on Main Street to the intersection of Wynn Street; thence east on Wynn Street and continuing east and south along Enloe Street to the intersection of Mayfield Street;

thence east on Mayfield Street to the intersection of Trammell Street; thence north on Trammell Street to Fellowship Road (LA Hwy 151);

thence east on Fellowship Road to the eastern Town limits;

thence north and west along the Town limits to the point where the western Town limits join Henry Street;

and thence south along Henry Street to the point of beginning.

Ward B (2)

Ward B (2) is comprised of all the area within the Town limits of Dubach lying within the following described line:

from a point of beginning where the western boundary of the Town limits intersects Hico Street (LA Hwy 151) thence east along Hico Street to the intersection of Rex Street; thence south along Rex Street to the point where Rex Street becomes Boulevard and continuing east on Boulevard to the intersection of Main Street; thence north along Main Street to the intersection of East Hico; thence east along East Hico and to the intersection of Pearl Street; thence north on Pearl Street to the intersection of Wynn Street; thence west along Wynn Street to the intersection of Main Street;

thence north along Main Street to the intersection of Smith Street; thence west along Smith Street to the intersection of McMillan Street (US Hwy 167); thence south along McMillan Street to the intersection of Wynn Street;

thence west along Wynn Street to the intersection of Church Street; thence south along Church Street to the intersection of Hico Street; thence west along Hico Street to the intersection of Larry Street; thence north along Larry Street to the intersection of Seth Street; thence west along Seth Street to the intersection of Henry Street; thence north along Henry Street to the point where the western Town limits intersect Henry Street;

thence west and south along the Town limits to the point of beginning.

Ward C (3)

Ward C (3) is comprised of all the area within the Town limits of Dubach lying within the following described line:

> from a point of beginning at the western town limits on Hico Street (LA Hwy 151);

thence east along Hico Street to the intersection of Rex Street; thence south along Rex Street to the intersection of Boulevard; thence east along Boulevard to the intersection of Main Street; thence north along Main Street to the intersection of East Hico Street; thence east along East Hico Street to the intersection of Pearl Street; thence north along Pearl Street to the intersection of Wynn Street; thence east and south along Wynn Street and Enloe Street to the intersection of Fellowship Road (LA Hwy 151);

thence west along Fellowship Road to the intersection of Annie Lee Street; thence west along Annie Lee Street to the point where Annie Lee Street intersects the Rock Island Railroad right of way;

thence west and south along the Rock Island Railroad right of way to the southern Town limits:

thence west and north along the Town limits to the point of beginning.

Ward D (4)

Ward D (4) is comprised of all the area within the Town limits of Dubach lying within the following described line:

> from a point of beginning of the point where the southern Town limit intersects the Rock Island Railroad right of way, continuing northeasterly to the intersection of the Rock Island Railroad right of way and Annie Lee Street; then southeasterly along Annie Lee Street to the intersection of Fellowship Road (LA Hwy 151);

thence east along Fellowship Road to the intersection of Graham Street; thence south along Graham Street to the intersection of Voss Street; thence west along Voss Street to the intersection of Nell Street; thence west along Nell Street to the intersection of McMillan Street (US Hwy 167);

the Rock Island Railroad right of way;
thence west and south along the Rock Island Railroad right of way to the southern
Town limits;
thence west and north along the Town limits to the point of beginning.

Ward D (4)

Ward D (4) is comprised of all the area within the Town limits of Dubach lying within the following described line:

from a point of beginning of the point where the southern Town limit intersects the Rock Island Railroad right of way, continuing northeasterly to the intersection of the Rock Island Railroad right of way and Annie Lee Street; then southeasterly along Annie Lee Street to the intersection of Fellowship Road (LA Hwy 151);

thence east along Fellowship Road to the intersection of Graham Street; thence south along Graham Street to the intersection of Voss Street; thence west along Voss Street to the intersection of Nell Street; thence west along Nell Street to the intersection of McMillan Street (US Hwy 167);

thence south along McMillan Street to the intersection of Oak Street; thence west along Oak Street to the Town limits of Dubach; thence west along the Town limits back to the point of beginning.

Ward E (5)

Ward E(5) is comprised of all the area within the Town limits of Dubach lying within the following described line:

from a point of beginning at the point where Oak Street intersects the southern Town limits line;

thence east along Oak Street to the intersection of McMillan Street (US Hwy 167): thence north along McMillan Street to the intersection of Nell Street; thence east along Nell Street to the intersection of Voss Street; thence south and easterly along Voss Street to the intersection of Graham Street; thence north along Graham Street to the intersection of Mayfield Street; thence east along Mayfield Street to the intersection of Trammell Street; thence northwesterly along Trammell Street to the intersection of Fellowship Road (LA Hwy 151): thence east on Fellowship Road to the point where the Town limits line crosses over to the north of Fellowship Road; thence northeasterly along the Town limits line to the easternmost point of the Town limits: thence south along the Town limits line to the southeast corner of the Town limits; thence west along the Town limits line to the point of beginning on Oak Street. Section 2. BE IT FURTHER ORDAINED that the map and plat of the Town of Dubach attached to this ordinance be accepted and declared to be a part of this ordinance dividing the Town of Dubach into five (5) Wards, the boundaries of which are shown on said map. Ward A is designated as "1"; Ward B is designated as "2"; Ward C is designated as "3"; Ward D is designated as "4"; and Ward E is designated as "5". BE IT FURTHER ORDAINED that this ordinance, in its entirety, Section 3. shall become effective and in full force and effect as of the date the submission by the Town of Dubach of its proposed redistricting plan is accepted by the United States Department of Justice. BE IT FURTHER ORDAINED that any and all ordinances or parts Section 4. of ordinances of the Town of Dubach in conflict herewith be and the same are hereby repealed.
