#### **ORDINANCE NO. 291**

# AN ORDINANCE PROHIBITING ANY DOG, CAT, OR OTHER DOMESTIC ANIMALS FROM RUNNING AT LARGE

#### **DUBACH ANIMAL CONTROL**

Pursuant to LA RS 3:2731, the Town of Dubach hereby enacts the following ordinance:

- 1. No person shall suffer or permit any dog, cat, or other domestic animal in his possession, or kept by him on his premises, to run at large on any unenclosed land, or trespass upon any enclosed or unenclosed lands of another.
- 2. The Town Police or any other Town employee shall have the authority to capture and pick up any animal running at large in violation of this ordinance, and to transport the captured animal to an appropriate place of confinement. If the animal so captured is wearing a collar with the owner's name and address, and a current rabies vaccination tag, the Town shall notify the owner of the animal's capture within three days of capture.
- 3. The owner of the animal shall have five days of capture or notice, whichever is shorter, to claim the animal, upon payment of the capture and confinement fee as may be set from time to time by the Town Gouncil. If the owner of the animal does not claim his animal within five days, the animal may be put up for adoption or disposed of in a humane manner.
- 4. The Town Council hereby establishes the capture and confinement fee to be that charged by the City of Ruston Animal Control Department.
- 5. Any citizen or officer may kill any dangerous or vicious dog, and no citizen or officer shall be liable for damages or to prosecution by reason of killing any dangerous or vicious dog.

# TOWN OF DUBACH ORDINANCE NO. 291-001

### AN ORDINANCE OF THE TOWN OF DUBACH AMENDING ORDINANCE 291

WHEREAS, it is in the interest of the public welfare to establish specific guidelines for animal control and penalties for violating same; and

WHEREAS, the Town of Dubach's ordinance needs to be amended to provide for a new confinement facility and other matters;

NOW THEREFORE, BE IT ORDAINED by Board of Aldermen of the Town of Dubach that the Ordinance Number 291 is hereby amended follows:

- A. Paragraph 2 of Ordinance Number 291 is hereby amended to read:
  - 5. The Town Police or any other trained employee designated by the Town shall have the authority to capture and pick up any animal running at large in violation of this ordinance, and to transport the captured animal to an appropriate place of confinement. If the animal so captured is wearing a collar with the owner's name and address and a current rabies vaccination tag, the Town shall notify the owner of the animal's capture within three days of capture.
- B. Paragraph 2 of Ordinance Number 291 is hereby amended to read:
  - 2. The Town Council hereby establishes the capture and confinement fee to be that charged by the contracted place of confinement.
- C. A new Paragraph is added to read:
  - 6. Violations of Paragraph 1 of Ordinance shall be punishable by a \$100 fine for a first offense and a \$500 fine for every violation thereafter.

BE IT FURTHER ORDAINED that if any portion of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

This Ordinance was duly introduced, the title of this ordinance was duly published in accordance with law, and then duly read and adopted on the <u>16<sup>th</sup></u> day of <u>February</u>, 2021 by the following votes:
