

ORDINANCE NUMBER 299

AN ORDINANCE EXTENDING THE NORTH BOUNDARY OF THE CITY LIMITS OF THE TOWN OF DUBACH.

SECTION 1: BE IT ORDAINED by the Council Members of the Town of Dubach that the North Boundary of the city limits of the Town of Dubach be extended to include the property described herewith:

The point of beginning is the intersection of the South line of the Northeast quarter of the Southeast quarter of Section 15, Township 20, Range 3 West, and the center line of U.S. Highway 167 (McMullen Street). From this point of beginning go West along the South line of the Northeast quarter of the Southeast quarter of Section 15, Township 20, Range 3 West, to the Southwest corner of the Northeast quarter of the Southeast quarter. Thence continue along the South line of the Northwest quarter of the Southeast quarter to the Southwest corner of the Northwest quarter of the Southeast quarter. Then proceed South along the West line of the Southwest quarter of the Southeast quarter to the Southwest corner of the Southwest quarter of the Southeast quarter, Section 15, Township 20, Range 3 West. From the Southwest corner of the Southwest quarter of the Southeast quarter, Section 15, Township 20, Range 3 West, proceed to the Northwest corner of the Northeast quarter of the Northwest quarter, Section 22, Township 20, Range 3 West. From the Northwest corner of the Northeast quarter of the Northwest quarter of Section 22, Township 20, Range 3 West, go South along the West line of the Northwest quarter of the Northeast quarter for a distance of 205 feet. Then proceed North 86 degrees, 58 minutes West for a distance of 408.3 feet. Thence proceed South 534 feet. Thence proceed South 86 degrees, 58 minutes East to the West line of the Northeast quarter, Section 22, Township 20, Range 3 West. Then proceed South along the West line of the Northeast quarter of Section 22, Township 20, Range 3 West, to the point where said West line intersects the existing North city limit line. From the point of intersection of the West line of the Northeast quarter of Section 22, Township 20, Range 3 West, and the existing North city limit line, proceed East along the existing North city limit line to the intersection of the existing North city limit line and the center line of U.S. Highway 167 (McMullen Street). From said point of intersection, proceed North along the center line of U.S. Highway 167 (McMullen Street) to the point of beginning. The area enclosed by the foregoing description is the property that is proposed for annexation into the town limits of Dubach.

SECTION II: BE IT FURTHER ORDAINED that this Ordinance shall be published in the official minutes of the Mayor and the Town Council in the manner provided by law.

SECTION III: THIS ORDINANCE shall become effective thirty (30) days following

adoption.
