

**Minutes of the Town of Dubach Board of Alderman
Regular Monthly Meeting
Monday, March 15, 2021**

Public Hearing was called to order by Mayor Ruby Dawson at 6:17 pm. Present were the following council members: Billberry, Dunn, Graham and Moerbe, and Roberts. A quorum was present.

Invocation was led by Billberry.

Pledge of Allegiance was conducted in unison.

Ordinance 410 – Expenditures was discussed by Mayor Dawson. She explained to the council and audience this ordinance pertained to expenditures outside of day-to-day operations that exceed \$500 must be brought before the council for approval. No motion was made during this time.

Public Comments Caleb from Ruston daily asked if any wording had changed in the ordinance from what was advertised. Mayor Dawson explained it had not changed. No other comments were made.

Regular Monthly Meeting began at 6:30 pm.

Adoption of Agenda Motioned by Roberts and seconded by Dunn to adopt agenda. Motion carried.

Adoption of the Previous Minutes Dunn motioned to accept previous minutes from February 16, 2021 and February 26, 2021. Billberry seconded. Motion passed unanimously.

Adoption of the February 2021 Financials Motion was made by Graham and seconded by Billberry to adopt financials. Motion carried unanimously.

Ordinance 410 – Expenditures Motion was made by Roberts and seconded by Dunn to adopt ordinance 410. Motion carried unanimously.

Resolution 411 – Community Development Week Mayor Dawson explained this resolution is in full support of Community Development week for April 4-9 and that we realize the importance and benefit of community development. Motion was made by Dunn and seconded by Roberts to accept the resolution. Motion passed unanimously.

Introduction of Ordinance 412 – Revoking the Dedication of Portion of Road and an Alley Evelyn Graham introduced Ordinance 410. She explained the attorney constructed documentation to revoke a portion of a road and alley owned by the town but will retain utility servitude and shall revert to the present owner(s) of the land adjoining. No motion was made. Will be voted on April 19.

Approval of an agreement with Jessie Sibley regarding the Town's property boundaries and the Hanna Estate Property Mayor Dawson explained the attorney established an agreement that both parties accept the property description described in the agreement of the Town's property and the boundaries between the properties created thereby for themselves, their heirs, successors, and assigns. Graham motioned to accept the agreement and Billberry seconded. Motion passed unanimously.

Cooperative Endeavor Agreement Mayor Dawson asked if this item can be tabled until next month's meeting. Motion to table was made by Dunn and seconded by Roberts. Motion passed.

Public Comments No comments were made.

Mayor Comments No comments were made.

Council Comments Monique Roberts requested ULM and CENLA be placed on next month's agenda for further questioning. Christopher Moerbe agreed because he have questions.

Adjournment was made by Roberts and seconded by Billberry. Motioned carried at 6:54 pm.
