After much discussion, it was determined to further research warranties and the quality of mowers and present it at the next meeting. No motion was made.

LGAP Community Center Project – Mr. Mickey Lewis Mayor Wilson told the council she was unable to get Mr. Lewis' quote before the meeting but she will later provide them with it. She also stated she has seen his contracting work and can assure he will not only do a good job but will do more for the monies provided. No motion was made.
