

The following ordinance was proposed by councilperson Evelyn Graham and seconded by councilperson Manique Roberts.

ORDINANCE NO. 387

An Ordinance amending Ordinance No. 387 to allow individual Town of Dubach council members to place items of business on the agendas of regular and/or special meetings of the Town of Dubach.

WHEREAS, the Town Council holds regular and/or special meeting for the Town of Dubach's business; and

WHEREAS, it is in the best interest of the Town of Dubach to allow individual members of the Dubach Town Council to place items of Business on the agenda of Town council meetings in order to transact the orderly business of the Town of Dubach.

NOW, THEREFORE, BE IT ORDAINED by the council of the Town of Dubach, State of Louisiana, acting as the governing authority of said Town that:

SECTION 1. Any member of the Dubach Town Council shall be allowed to place items on the agenda of a regular meeting if received no later than 4:00 p.m. on the Wednesday immediately preceding the regular meeting.

SECTION 2. Any member of the Dubach Town Council shall be allowed to place items on the agenda of a special meeting if received no later than 24 hours prior to the time fixed for the special meeting to permit sufficient time to satisfy the requirements set forth in La. R.S. 42:19.
