ORDINANCE NO: 438
2025/2026 Annual Budgets

AN ORDINANCE OF THE TOWN OF DUBACH ADOPTING THE GENERAL FUND BUDGET, THE WATER/SEWER BUDGET, THE CEMETARY BUDGET, AND GARBAGE FUND BUDGET FOR THE FISCAL YEAR, BEGINNING JULY1, 2025 AND ENDING JUNE 30, 2026.

WHEREAS, an ordinance has been proposed to be adopted by the Board of Aldermen of the Town of Dubach; and

WHEREAS, the proposed ordinance must be introduced by its title; and

WHEREAS, a public hearing must be held prior to its adoption; and


WHEREAS, the title of the proposed ordinance must be published in the official journal and the notice shall provide for the time and place where the Board will consider it's adoption.

NOW THEREFORE, BE IT ORDAINED, that the following ordinance be and it is hereby adopted by the Board of Aldermen of the Town of Dubach.

- Section 1: Be it Ordained that the proposed annual budget for the fiscal year beginning July 1, 2025 and ending June 30, 2026 is hereby adopted and shall serve as the Budget of the Town of Dubach for the fiscal year ending June 30, 2026.
- Section 2: The Adoption of this Budget be and the same is hereby declared to operate as an appropriation of the amount therein set forth within the terms of the budget classifications and approval of the expenditure of such funds.
- Section 3: Amounts are available for expenditures only to the extent included with the said Budget.
- Section 4: This Ordinance shall become effective after its promulgation all in the manner and form prescribed by law.
- Section 5: This Ordinance was adopted after a public hearing, after the budget was available for inspection, and after all public notices of same were published as required by Louisiana Revised Statute 39:1306, 1307, & 1308.

This Ordinance was duly introduced, the title of this ordinance was duly published in accordance with the law and then duly read and adopted on the ___ day of May, 2025 by the following votes:
